The Principality is a sovereign and independent State within the framework of the general principles of international law. The territory of the Principality is unalienable. Art. 2. The principle of government is a hereditary and constitutional monarchy. The Principality is a State under the rule of law, committed to fundamental freedoms and rights.

The Principality is a constitutional, hereditary monarchy on a democratic and parliamentary basis (Art. 79 and 80); the power of the State is inherent in and issues from the Prince Regnant and the People and shall be exercised by both in accordance with the provisions of the present Constitution.

Executive power is vested in the Sovereign and is exercisable by the Sovereign's appointed representatives, and extends to the execution and maintenance of this Constitution, and of the laws of the Principality of Hutt River. The Sovereign is the head of the Defence Forces and chairs the Councils and Superior Committees of National Defence.

The Principality of New Utopia shall be a Constitutional Monarchy. Article 4: LANGUAGE. English shall be the official language of the Principality of New Utopia. Article 5: PRINCIPLES OF LAW. 1. The Constitution of Liechtenstein was promulgated on 5 October 1921, replacing the 1862 constitution. It was granted by Johann II, Prince of Liechtenstein, and established the rule of parliamentary democracy mixed with that of constitutional monarchy, as well as providing for referendums on decisions of the Landtag. It also abolished the three seats in the Landtag appointed by the Prince and lowered the voting age from 24 to 21.
